I am to inform that in the reference 1st cited, notification has been issued for filling up of 648 backlog vacant posts of MPHA (F)/ANM Grade-III in Village / Ward Secretariats in the State.


The Commissioner, PR & RD Department in the reference 2nd cited has requested to reconfirm the vacancies of MPHA (F)/ANM Grade-III. Accordingly after obtaining the information from the Districts, it was informed in the reference 3rd cited that the MPHA (F)/ANM Grade-III vacancies increased from 648 to 677 vide reference 3rd cited.

In the reference 4th cited, the Commissioner, PR & RD Department has again requested to re-confirm the vacancy position as published in the Notification, if any change in the number of vacancies arises and requested for necessary Corrigendum accordingly.
